CANDIDATE STATEMENT TO BE FILLED UP PRIOR SUBMITTING REGISTRATION

As a representative and on behalf of the candidate team,

- I hereby declare that I have read, understood, and agreed this Application File and in particular the registration conditions for the 2016 championship of "F4 Spain Championship" (hereinafter referred to as "F4 Spain Championship").
- I request, with full knowledge of the facts, an invitation to take part in the 2016 F4 Spain Championship.
- I understand that the F4 Spain Championship Organizing Committee needs to limit the number of competitors and, consequently, to select the candidates on the basis of criteria it deems appropriate to the spirit of the series, as well as the sporting and economic requirements it must meet.
- I therefore understand that my application may not be approved and I accept this possibility with full knowledge of the facts. In signing this statement, I relinquish the right to contest the decision of the Organizing Committee before a sporting or justice court.
- I understand that filling in the information form that makes part of the Application File does not constitute, under any circumstances, a commitment by the Organizing Committee to accept my application for the 2016 season of the F4 Spain Championship, or for any of the following seasons.
- I accept that if the installments deadlines mentioned in the participation contract are not respected by the Candidate, the Organizing Committee, in its full discretion, can declare my application as null and void. In that case, the candidate will not be paid off the amount of the installments.
- In case of false or incomplete declarations, I hereby acknowledge and accept that his/her application cannot be taken into consideration.
- Whatever the circumstances, I hereby accept that any dispute arising from the interpretation or use of this document, and for which it has not been possible to reach an amicable settlement between the Parties, shall be submitted for judgment to the sporting tribunals of the Real Federacion Española de Automovilismo (R.F.E.d.A) and, if necessary, the competent courts of Barcelona. Spanish law shall apply.

APPLICATION FILE FORMALITIES AND MANDATORY SUPPORTING DOCUMENTS

- Each page of this file should be signed, and the signature should be preceded by the handwritten wording "read and approved".
- By January 31st, 2016 at the latest, this application file should be completed and sent to: alexandra@f4spain.com
- The Application File submission fee should be paid by January 31st, 2016, for an amount of €2.000 (+21% VAT if applicable) per car, by bank transfer only.
- The Organizing Committee will pre-select the teams admitted to participate to the 2016 F4 Spain Championship by April 15th 2016.
- For selected candidates, the first installment shall be considered as advance payment of entry fees for the 2016 F4 Spain Championship and shall not be refundable.
- For candidates that are not selected, this sum shall be refunded based on the decision of the Organizing Committee. However if a selected team decides to withdraw, the entry fees won't be refunded.
- The competitors accept that the balance, corresponding to €13.000 of the 2016 F4 Spain Championship entry fees (€15.000 per car - advance fee of €2.000) must be paid by bank transfer only:
 - by March 31st, 2016, for the second part, €6.500 (+21% VAT if applicable) per car
 - by July 10th, 2016, for the third and last part, €6.500 (+21% VAT if applicable) per car
- The entry fee includes 8 events (7 championship events and 1 non-championship event), 6 official testdays, tire fitting truck, spare parts truck, technical support, organization truck, timekeeping, fuel delivery and catering service for an additional fee of 11€/pax.

GENERAL PROVISIONS

1. PREAMBLE

- The 2016 F4 Spanish Championship ("The Championship") is being organized by Koiranen GP S.L (the "Promoter")
- The Championship is a 8 events championship, held in . The prize money will be of €50.000 for the winner, €30.000 for the second and €10.000 for the third.
- The 2016 F4 Spanish Championship is conducted in accordance with the Sporting and Technical Rules of the Championship which will be published no later than March 1st, 2016.

2. ADMISSION

- In order to participate in the 2016 F4 Spanish Championship, the Applicant must:
 - (i) be at least 15 years of age as of May 19th, 2016
 - (ii) have a valid national licence
 - (iii) not have won any higher single-seater category

3. RIGHTS GRANTED TO DRIVERS ENTERING THE 2016 F4 Spanish Championship

- 3.1 The Applicant will be entitled, subject to the payment of the Registration Fee in accordance with provisions of Section 4 below and their compliance at all time with the Series Rules, to participate in all Events of the 2016 F4 Spanish Championship (as defined in the 2016 F4 Spanish Championship Rules).

4. RACING APPAREL

- Each Applicant must guarantee that the Driver's apparel is in accordance with the FIA Regulations.

5. COMPLIANCE WITH APPLICABLE LAWS

- With respect to the subject matter hereof, the Promoter shall comply in all material respects with all applicable laws. Without limiting the foregoing, the Promoter shall comply with all privacy and data protection laws ("Privacy Laws"), which apply to personal information received in connection with this Application. All such personal information will be used exclusively for the purpose of processing this Application and will not be disseminated to any third party, other than race officials and the Promoter's agents and representatives, as necessary, and except as required by law or by a court of competent jurisdiction.

7. LEGAL NOTICE

- All claims and disputes between the Promoter and the Applicant or Driver, or his/her/its spouse, estate, heirs, successors, or assigns relating in any way, directly or indirectly, to the Application for admission to or participation in the F4 Spanish Championship shall be governed by and construed and interpreted in accordance with the laws of Estonia, excluding however, that state's conflicts of laws rules as though the event or obligation giving rise to same had been conducted or occurred entirely within Barcelona, Spain.
- All such claims or disputes shall be resolved in federal or state court in the State of Barcelona and in no other jurisdiction. The Promoter and the Applicant or Driver irrevocably consent to the personal jurisdiction of such Barcelona Courts for the purpose of resolving such disputes, and waive all defenses and motions based upon inconvenient or incorrect forum. Any resulting judgment may be enforced by the courts or otherwise under the laws of any jurisdiction in any country where the Promoter, Applicant or Driver may be found.
- In any such action, the substantially prevailing party shall receive reimbursement of its expenses, including but not limited to reasonable attorneys and other legal fees and costs.
